First Lady Praises Philanthropy Leaders

First Lady Anne Holton celebrated and praised the recipients of the 2008 Chancellor's Award for Leadership in Philanthropy. Delivering the keynote address at Country Club of Virginia luncheon honoring the recipients on April 23, Ms. Holton acknowledged their contributions to community colleges across the state. "Hearing about these honorees and how they have stepped outside of themselves to give back to the community reassures me about the spirit of humanity," said Ms. Holton.

The Chancellor's Award for Leadership in Philanthropy was created in 2006 to honor outstanding community college supporters across Virginia. These philanthropists have demonstrated a passion and commitment to ensuring that deserving people receive the advantage of a college education.

Each philanthropy leader becomes the namesake for one of 23 Commonwealth Legacy Scholarships, which are awarded to a student attending the community college in their area. This year, the **Wachovia Foundation** provided funds to sponsor these scholarships.

The Virginia Foundation for Community College Education surprised Barbara and Mark Fried at the luncheon by announcing the *Barbara and Mark Fried Commonwealth Legacy Scholarship Endowment for Great Expectations*. The Frieds have been advocates of the community college system for years and have been instrumental in launching a challenge grant for the *Great Expectations* program. More than \$100,000 was raised to establish the scholarship endowment.

"These distinguished individuals are sharing with us their secrets to make a better tomorrow. They are giving of themselves, improving people's lives by affording them the opportunity of higher education," said Glenn DuBois, Chancellor of Virginia's Community Colleges.

Barbara and Mark Fried Commonwealth Legacy Scholarship Endowment for *Great Expectations*

During a special presentation at the Chancellor's Award for Leadership in Philanthropy luncheon, Mark and Barbara Fried were surprised by the VFCCE, Chancellor DuBois and First Lady Anne Holton with an endowment bearing their names. Selected for this surprise endowment for their commitment to expanding affordable access to higher education, Barbara and Mark Fried are tremendous supporters of Virginia's Community Colleges. Their most recent contribu-

tion was a generous challenge grant to develop a bold, ambitious, and innovative program—*Great Expectations*—to expand community college opportunities for emancipated foster care youth.

The endowment will award annual scholarships to two deserving foster care youth.

We are honored to pay tribute to a couple who has lead by example and challenged others to do the same.

New Leadership gives Momentum to *Great Expectations*

Joining Virginia's Community Colleges as the Project Director for the *Great Expectations* initiative, Carol Underhill brings leadership and momentum to the project for foster care youth. With a background in designing and developing new education programs, along with extensive experience in development and fundraising, Ms. Underhill will oversee the VCCS/Virginia Foundation for Community College Education's *Great Expectations* transitional education program for foster youth.

Pilot programs start this fall at five community colleges throughout the state. These colleges will host after-school programs for students ages 13 to 17 and comprehensive programs for foster care youth and alumni ages 18 to 24 to help them gain access to a community college education—and move on to employment opportunities and a successful life. Additionally, an online resource center will be created to provide foster youth, social services personnel, counselors and career coaches, and foster and biological parents a central place to access all services.

"I'm very excited to launch this project and hope that in partnership with the First Lady's 'For Keeps' initiative and the VA Department of Social Services, we will be able to make the initiative as robust as possible and reach out to all foster care youth who need our support," Ms. Underhill said.
